As per you request, I am happy to provide you with a letter of reference with respect to the civil construction works you carried out for Bluhm Burton Engineering for the two refrigeration and air cooler installations at AngloGold Ashanti's KM and GC Shafts. In fact, with the project just about complete, it provides me with a good opportunity to express my thanks for the way in which the project has gone.

Our initial concerns about using a local (Ghanaian) contractor, soon subsided after we saw your modern fleet and equipment and the quality of Consar's workmanship at one of your other sites. Given the fast track requirement to have the first installation at KMS ready for December 2005, your team moved to site within days of contract award at beginning of May and earthworks commenced during site establishment. You were set an ambitious programme at KMS which you managed to achieve without sacrificing quality or safety.

Your teams are well managed and supervised, your plant is well maintained, the site is always kept neat and tidy and the result is a quality product. I have noticed attention to detail during construction that has not had to be spelt out in long contractual specifications or site instructions. In fact input from BBE, beyond the usual site supervision and quality control measures, during construction has been minimal.

As the project draws to a close your team has notched up 300 000 man-hours work without a single lost-time injury and will be suitably rewarded during my next visit. This is especially commendable given the amount of work that was done at height (up to 15 m)

#### To Whom It May Concern:

This letter confirms that CONSAR LTD. has been contracted on Gold Field Ghana Ltd.'s Tarkwa Phase IV Project for the supply and placement of all project concrete and block building structures. CONSAR was contracted to Gold fields Ghana Ltd. On a unit rate contract that was managed and supervised by our project EPCM consultant, Lycopodium Pty Ltd. of Perth Australia.

During the period beginning August 2003 to date, CONSAR has placed ~11,500 m<sup>3</sup> of structural concrete in accordance with the project specifications and drawings. The contractor prepared all concrete in its own batch plant and delivered it to site locations using its own fleet of mixer trucks, including its newly acquired pump truck with extendable boom. Concrete was prepared using high quality sand and aggregate from the contractor's granite quarry located near Komasi, and cement produced here in Ghana. During the course of its work, the contractor's concrete consistently exceeded the structural strength requirements set out in the design and there was no work rejected, on the basis of concrete strength or installed quality. The contractor also bent and placed all reinforcing steel bars and erected all form work for plant footings, plinths, walls and slabs, including several large suspended slabs. Using a combination of metal shutters and site-built wooden forms, the contractor successfully cast all shapes and sizes of installations to design tolerances and achieved good surface finishes. In the few locations where surface defects occurred, they were quickly repaired or patched in an acceptable manner.

The contractor utilized expatriate lead supervisors and other national supervisors with many years experience in its organization. The majority of the laborers were locally hired and trained by the contractor. The contractor struggled at times to fulfill the requirements of our stringent safety program and was involved in the project's only serious accident which was a fatality; however it supervisors





diligently worked with the EPCM consultant to improve and train the national work force. During the course of its activities at Tarkwa, the contractor had no serious environmental incidents and was always responsive to our Project Team's requests to improve housekeeping and dispose of its waste materials in accordance with our requirements.

In summary, we are pleased with the results obtained by CONSAR LTD and we would definitely consider using its services on any future project. Please feel free to contact me personally should you have any questions regarding the capabilities or activities of CONSAR LTD on our project.


